The Department of Fisheries, Ministry of Primary Resources and Tourism invites proposals from interested parties to design, build, operate and maintain for the modernisation and redevelopment of the Muara Fish Landing Complex in Brunei Darussalam.

The objective of this project is:

- To accommodate the increasing throughput from the fisheries industry at Muara FLC due to the increase number of users including fishing boats, buyers, processors, service providers;
- Provide adequate ancillary facilities in line with the projected throughput required by the capture fisheries, offshore and inshore aquaculture activities, and processing operations;
- To improve the fish landing jetty to support food safety and hygiene requirement, including improvement of landing and mooring capacity as well as safe berthing for fishing vessels and support boats;
- To create a safe working environment for workers and general users of the Muara FLC;
- To generate more employment opportunities for the locals.
